As part of the Section 36C application, the Applicant is seeking to vary the wording of certain conditions contained in Annex 2 of the current Section 36 Consent and deemed planning permission conditions to reflect the changes to the Description of the Development and the Section 36C EIAR.

The Consented Development was awarded Section 36 planning consent in August 2022 and by 2023 the Applicant had progressed with ground investigations and detailed design of both the Site Enabling Works and the main wind farm. Site Enabling Works were completed in 2024.

Documents required to satisfy pre-commencement elements of several planning conditions, for either the Enabling Works or Main Works, were submitted to The Highland Council over the course of 2023 and 2024.

As the Proposed Varied Development construction methodology and mitigation remain largely unchanged, the majority of the information and documents submitted to satisfy the conditions will also not change. It is therefore considered that these documents will remain valid for the Proposed Varied Development and, on this basis, some conditions will remain 'satisfied'.
